Adams County Volunteer Hours

Our 2016 Adams County Volunteer Hours (CVHs) total was 17,294 hours (5,867 HCE/11,427 Other Community), down from last year. We totaled 17,294 hours with only 79% of our membership reporting. A reminder that CVHs in 2017 reporting will continue to be separated between HCE Hours and Other Community Hours. It is highly encouraged for unit recorders to gather hours each month. Our goal for 2017 is to have 80% reporting!

Walk Around Adams County 2017 Challenge

If you did not participate in 2016...2017 can be your year!

Please consider recording your activity. Did you take advantage of the break in our weather patterns for February and get out for a bike, walk, or run? Have you become a regular at the KROC Center or YMCA? How is your math? Are you able to figure out mileage from your pedometer steps or equivalents?

Just in case you have not, here is water activity example ... Water jogging class yields 242 steps per minute ... your class was 30 mins (multiply steps per minute by 30 minutes) and then divide by 2,100 (1 mile = 2,100 steps). 242 x 30 mins = 7,260 divided by 2,100 = 3.46 miles in 30 minutes. Record your activity in this manner all year and at the end of the year you can celebrate your accomplishments, who knows...you may even come in 1st place with the most mileage!

Florence Harding

First Lady 1921-1923

Florence "Flossie" Mabel King Harding, previously DeWolf (Aug. 16, 1860-Nov. 21, 1924), was the wife of President Warren G. Harding and First Lady of the United States from 1921 to 1923.

She married the somewhat younger Harding when he was a newspaper publisher in Ohio, and she was acknowledged as the brains behind the business. Known as The Duchess, she adapted well to the White House, where she gave notably elegant parties.

She was born Florence King in Marion, OH, the eldest of three children of Amos King, a prominent Marion banker of German decent, and Louisa Bouton King, whose French Huguenot ancestors had fled religious persecution.

Aiming to become a concert pianist, Florence began studies at the Cincinnati Conservatory of Music, but at 19, she eloped with Henry Athenton DeWolf and they were married in Columbus on Jan. 22, 1880. On September 22, 1880, Florence gave birth to her only child, Marshall Eugene. The couple separated not long after the birth of her son and were divorced in 1886.

In 1890, Florence became engaged to Warren Gamaliel Harding, owner of the Marion Star, and at 25, her junior by five years. They married on July 8, 1891. They had no children of their own, but Florence's son Marshall lived with them intermittently, and received encouragement from Warren to work in journalism.

During her husband's illness, Florence became business manager of the Marion Star. One of the newsboys, Norman Thomas, later the Socialist presidential candidate, declared that Warren was the frontman, but Florence was the real driving power of the Marion Star.

In 1905, Florence needed emergency surgery for nephritis (floating kidney), and was treated by Dr. Charles E. Sawyer. His close links with the Harding family and Florence's total trust and dependence on him would later prove controversial. During her convalescence, Warren began an affair with a close friend of hers, Carrie Phillips.

By 1914, Warren's political career had taken him to the U.S. Senate, greatly helped by Florence's management of his finances, social life and public image. By 1920, he was a contender for the Republican presidential nomination, though not a front-runner. Washington clairvoyant 'Madame Marcia' Champrey correctly forecast that Warren would become President, but added that he would die in office. The election was overshadowed further by attempted extortion by Carrie Phillips, threatening to reveal Warren's adulterv.

On March 4, 1921, Florence became First Lady, immediately taking an active role in national politics, at times even appearing to dominate the President. She had a strong influence on the selection of government ministers. She made her views known on everything from the League of Nations to vivisection, racism, and women's suffrage. As a White House hostess, she presided over elegant parties where her husband would refer to her as The Duchess.

By 1923, both Florence and her husband were suffering from dangerous illnesses, but still

undertook a coast-to-coast rail tour. Florence proved highly popular at their many scheduled stops, but Warren was visibly ailing. After a bad reaction to seafood, he was rushed to San Francisco's Hotel, where he died. On this tour, Warren had been under the care of Dr. Charles E. Sawyer, who is believed to have misdiagnosed the President's condition and administered stimulants that brought on his fatal heart attack. As Florence did not request an autopsy and also destroyed many of his papers, a conspiracy theory was put forward in a semi-fictional book "The Strange Death of President Harding," sensationally claiming that Florence had poisoned her husband.

Florence's kidney ailment returned and, at the advice of Dr. Sawyer, she took a cottage in the grounds of his sanitarium in Marion. Her last public appearance was at the local Remembrance Day parade, where she stood to salute the veterans. A few days later, she died of renal failure.

Florence and Warren Harding are the only presidential couple to have died within the time of the president's elected term of office.
